INTERIM CHAIR'S UPDATE REPORT

Purpose

My focus has been to consider inequalities, community empowerment and ensuring the voice of young people is heard.
- On 14 June I did my first Speakers for Schools broadcast to around 400 young people covering my career and my interest in ensuring young people have the opportunity to influence and design public services.
