#### 1. INTRODUCTION

- 1.1. Wylie & Bisset were appointed as the External Auditors of Jewel & Esk College with effect from 1 August 2006 for a period of 5 years until 31 July 2011. Wylie & Bisset LLP succeeded Wylie & Bisset as auditor in 2008 and will undertake the remainder of the appointment.
- 1.2. Our audit was carried out in accordance with our statutory responsibilities, statements of auditing standards and wider responsibilities contained in the Code of Audit Practice (the 'Code') issued by Audit Scotland in March 2007.

Paragraph 19 of the 'Code' states that the auditor's objectives are to:

- Provide an opinion whether the College's financial statements present a true and fair view of the financial position of the College and the regularity of transactions in accordance with standards and guidance issued by the Auditing Practices Board;
- Review and report on the College's corporate governance arrangements as they relate to:
  - The College's review of its systems of internal control
  - The prevention and detection of fraud and irregularity
  - Standards of conduct, and the prevention and detection of corruption
  - Its financial position, and
- Review aspects of the College's arrangements to manage its performance.
- 1.3. The responsibilities of the Board of Governors with regard to the financial statements are set out in the "Statement of Responsibilities of the Board of Governors" included in Appendix A and in the "Independent Auditors' Report" in Appendix B.
- 1.4. The responsibilities of Wylie & Bisset LLP with regard to the financial statements and our audit opinion on the financial statements are included in the "Independent Auditors' Report" included in Appendix B.
- 1.5. Our audit report on the financial statements for the year ended 31 July 2010 is unqualified.

#### 2. INTERNAL CONTROLS AND AUDIT APPROACH

- 2.1. We have reviewed in the course of our audit the key elements of the College's systems of internal financial controls in the main operating cycles.
- 2.2. In carrying out our audit work we have taken into account the following:
  - a) The College's internal control procedures;
  - b) The College's Governance procedures;
- 2.3. In reaching our audit opinion we carried out our audit work based on the audit plan with evidence obtained by:
  - a) Discussions with senior management and staff at the College;
  - b) Completing appropriate audit programmes;
  - c) Carrying out analytical review procedures;
  - d) Carrying out substantive and compliance audit tests on a judgemental basis; and,
  - e) Review of minutes of Board and management meetings.
- 2.4. Based on our review we have identified certain areas where the operation of internal financial controls could be improved. These areas are included within sections 8 and 9 of this report.
- 2.5. As part of our procedures during the current year we have also revisited the areas noted in the prior year in order to assess whether adequate improvements have been made. The results of these follow up procedures and any subsequent recommendations are included within section 5 of this report.
- 2.6. Our recommendations have been graded as either High, Medium or Low priority depending upon the degree of risk assessment for each recommendation.
- 2.7. Management have been asked to respond to our recommendations and to identify the person responsible for implementation along with a projected timescale. These responses are included alongside our recommendations.
- 2.8. Note that the Governors of the College are responsible for safeguarding the assets of the College and hence for taking steps for the prevention and detection of fraud and other irregularities.



#### 3. FINANCIAL STATEMENTS

- 3.1. The financial statements of the College are the means by which it accounts for its stewardship of the resources made available to it and its financial performance in the use of these resources. In accordance with the Further and Higher Education (Scotland) Act 1992 and the Accounts direction issued by the SFC, it is the responsibility of the College to prepare financial statements, which give a true and fair view of the College's financial position and the income and expenditure for the year.
- 3.2. The Public Finance and Accountability (Scotland) Act 2000 requires that the auditor shall place on the abstract of accounts an audit report, which contains an opinion as to whether the College has fulfilled this responsibility. The format of the audit report directed by the Auditor General for Scotland clarifies the respective responsibilities of management and auditors in relation to the accounts and requires auditors to set out the basis on which they have formed their opinion.

#### **AUDIT REPORT**

3.3. We are pleased to record that there are no qualifications in our audit report on the College's 2009/10 accounts, as, in our opinion, the financial statements give a true and fair view of the College's financial position and the income and expenditure for the year ended 31 July 2010; and funds received have been applied for their intended purpose.

#### **FINANCIAL PERFORMANCE**

- 3.4. The retained result of the College for the year is a surplus of £388k. This is stated after an exceptional expense of £1,000k and a credit arising in relation to the pension scheme past service gain of £1,208k.
- 3.5. Exceptional cost in the year relates to a bad debt write off of £1,000k when a significant debtor of the college got into financial difficulties during the year. The initial debt of £1,940k related to the proceeds receivable on the sale of land at Milton Road. Following non payment of the debt, ownership of the land was retained by the College. This has been included within the accounts at current valuation in part settlement of the debt with the remaining balance being written off.
- 3.6. The reinstated land has been disclosed as an addition to fixed assets and held within the land and buildings category. This is property which is surplus to the College's requirements and hence, in accordance with the SORP, has been included at market value. Additional disclosure has been included within the accounts to highlight that this land is available for sale.
- 3.7. The pension scheme past service gain arises mainly in relation to the impact of the change in pension scheme valuation to take account of CPI rather than RPI and is as determined by Hymans Roberton, the pension scheme actuaries. Note that this is considered further within section 10.



- 3.8. In 2009/10, the College had forecast for an operating surplus of £23k in 2009/10 through the College Financial Return. The College has currently budgeted for a surplus of £281k in 2010/11.
- 3.9. The consolidated balance brought forward on the income and expenditure reserve as at 1 August 2009 was £13,929k: the balance on the income and expenditure reserve at 31 July 2010 is £12,996k. Note however that these figures include a designated reserve of £9,560k and £8,560k for 2009 and 2010 respectively which were created to recognise the proceeds received in relation to the land sale to fund the new campus development. Whilst disclosure of designated reserves is not required under the SORP it was agreed with management that given the size of the balance in question, this disclosure was required in order to provide a user of the account with a true and fair view of the situation.

#### SUBMISSION OF WORKING PAPERS

3.10. The financial pages of the accounts submitted for audit were substantially complete and revised soon after our audit to include the final financial information. Working papers provided have been of a good standard and queries arising from the audit have all been resolved. Key staff members were available for consultation throughout the audit process.

#### **ISSUES ARISING**

- 3.11. During the course of the audit a number of issues arose which were resolved in discussion with, or formally reported to the Head of Finance and the Financial Director. This practice is an established part of the audit process. The remainder of this report draws to the attention of the Board of Governors and the Auditor General any matters of particular significance or interest, which arose from the audit.
- 3.11 **Accounting Policies**: In accordance with FRS18, the Audit Committee has formally reviewed the accounting policies included in the Annual Accounts. We have not identified any instances where we consider the accounting policies to be in appropriate.
- 3.12 **Campus Development**: The campus development was completed during the previous year (ended 31 July 2009). Final snagging costs remain to be settled with construction companies.
- 3.13 **Exceptional item**: During the year, the debt remaining in relation to the sale of land at Milton Road went bad following failure of the debtor to maintain adequate financing. The debt has been settled in part by the re-recognition of the asset which has been returned to the College with the remainder of the balance being written off. Due to the size of the balance in question this has been treated as exceptional expense and disclosed separately on the face of the Income and Expenditure account.
- 3.14 Appendix C includes a copy of the letter of representation which we have sought from the Governors in support of the matters reported to us during our audit procedures. This also includes reference to the summary of unadjusted errors and deviations. There were no errors or deviations identified during our procedures which have not been amended within the accounts.



#### 4. INTERNAL AUDIT

#### **Objective and Approach**

- 4.1. Internal audit is a key element of the internal control system set up by management. A strong internal audit function is necessary to ensure the continuing effectiveness of the internal control system established. The College, therefore, needs to have in place a properly resourced internal audit service of good quality. To maximise the reliance that may be placed on internal audit and to avoid duplication of effort, the adequacy of internal audit is assessed each year.
- 4.2. The College's internal auditors during 2009/10 were Baker Tilly. This was a new appointment during the year, the previous internal auditor, Scott Moncrieff, having reached the end of their appointment term.
- 4.3. In the course of the year ended 31 July 2010 the following internal audit reports were issued:
  - a) Management Reporting
  - b) Human Resources and Payroll Procedures
  - c) Network Management and Security Review
  - d) Bursary Payment Process
  - e) Health & Safety (not available at time of audit)

#### **Opinion**

4.4. Our audit procedures included an assessment of the adequacy of the Internal Audit function using a bespoke checklist and review of the reports issued by Internal Audit function. Minutes of the audit committee were also reviewed. Our findings in this area proved satisfactory allowing us to conclude that the internal audit function is operating effectively and that we could place formal reliance on work of Internal Audit.



#### 5. CORPORATE GOVERNANCE

#### **Objective and Approach**

- 5.1. A review and assessment of the College's Corporate Governance systems relating to standards of conduct, openness and integrity was performed as part of our audit procedures using a bespoke checklist. We also reviewed the following:
  - a) The College's Corporate Governance Statement included in the financial statements for the year ended 31 July 2010;
  - b) The College's revised Risk Register;
  - c) The minutes of meetings of key College committees issued during the year.

#### **Opinion**

5.2. Based on our review, we are satisfied that the College operates appropriate Corporate Governance procedures and that management have adequate arrangements in place covering standards of conduct etc. We found no matters therein to impact upon our audit opinion.

#### **Recommendations**

5.3. Two recommendations relating to this area were made in 2009, being Board Committee Meeting Attendance and Related Party Disclosures. These have been followed up during the current year and subsequent recommendations made as appropriate. This is considered within section 8 & 9.



#### 6. VALUE FOR MONEY

#### **Objective and Approach**

6.1. We have considered the College's strategy regarding value for money as part of our standard audit procedures. It is noted that whilst there have been no specific VFM studies carried out by the College's internal auditor during the year, implicit assurance over this area is obtained via all the internal audit reviews.

#### **Opinion**

6.2. Based on our review, we are satisfied that the College has established adequate arrangements to secure economy, efficiency and effectiveness in the use of its resources.

#### **Recommendations**

6.3. There were no recommendations relating to this area in 2009. No recommendations pertaining specifically to Value for Money have been made during the current year.



#### 7. PREVENTION AND DETECTION OF FRAUD AND IRREGULARITIES

#### **Objective and Approach**

- 7.1. Best practice requires that the College should establish arrangements for the prevention and detection of fraud and other irregularities as part of its Governance procedures.
- 7.2. An assessment was made of the adequacy of the systems and controls for the prevention and detection of fraud and irregularities during our audit procedures.
- 7.3. In the course of the audit we have reviewed the following areas with regard to the prevention and detection of fraud and irregularities:
  - a) The monitoring and compliance with financial procedures;
  - b) The College's strategy to prevent and detect fraud and other irregularities;
  - c) The internal controls operated for segregation of duties, authorisation and approval processes and reconciliation procedures.
- 7.4. No areas of significant concern were found during normal audit procedures however one potential control weakness was identified. This is included within section 9 of this report.
- 7.5. We emphasise that our audit of the financial statements is planned to ensure there is a reasonable expectation of detecting misstatements arising from fraud or other irregularity that are material in relation to those financial statements, but cannot be relied upon to detect all frauds and irregularities.

#### **Opinion**

7.6. Overall we concluded that management has an adequate approach to fraud prevention and detection and has reasonable controls in place to ensure that potential areas for fraud are detected and dealt with in an appropriate manner.

#### **Recommendations**

7.7. There is one recommendation made specifically in relation to this area (9.2) however, it is highlighted that all recommendations made have an implicit impact on the prevention and detection of fraud and other irregularities.



#### 8. MANAGEMENT LETTER – 31 July 2009

- 8.1. A management letter was prepared by Wylie & Bisset in relation to the accounts of Jewel & Esk College for the year ended 31 July 2009.
- 8.2. This included four observations along with our recommendations to management. As part of our audit procedures during the current year we have followed up the areas highlighted and include below our conclusions from the current year are detailed below.

#### **PRIORITISATION**

8.3. The points within the report have been assigned a priority level based on the urgency required in addressing the matters highlighted. An explanation of the priority is as follows:

**High Priority** - Recommendations addressing significant control weaknesses which should be implemented immediately.

**Medium Priority** - Recommendations addressing significant control weaknesses which should be addressed in the medium term.

**Low Priority -** Recommendations which, although not addressing significant weaknesses, would either improve efficiency or ensure that the College matches current best practice.

#### **31 JULY 2009 RECOMMENDATIONS**

#### 8.4. **ELCG sales invoicing**

- 8.4.1. **2009 Observation**: It was noted that income due to the college in relation to the Lothian Colleges partnership had not yet been invoiced to the associated Colleges although the account reconciliation last carried out in February 2009 indicated that Jewel & Esk College would send out invoices in March 2009. Although the amount involved was not significant in terms of materiality (£5,767), the delay in invoicing was detrimental to the organisations cash flow and increases the risk associated with the ultimate collection of the balance.
- 8.4.2. **2009 Recommendation**: We recommended that the invoicing for ELCG be sent out so that the income could be recouped as soon as possible.
- 8.4.3. **2009 Management Response**: Agreed. There appears to have been an oversight with this particular inter-college invoice. However, procedures have been tightened and the invoice in questions was raised in September.
- 8.4.4. **2010 Update**: Satisfactory. No instances of non invoicing noted in the current year. No further action required.



#### 8.5. Bank Reconciliations

- 8.5.1. **2009 Observation**: Our audit procedures highlighted that one of the bank reconciliations prepared for May '09 had not been signed as reviewed/authorised. Consequently, no evidence of review of the reconciliation has been maintained.
- 8.5.2. **2009 Recommendation**: We recommended that the College ensure all bank reconciliations are reviewed once prepared and signed as such to evidence the review.
- 8.5.3. **2009 Management Response**: It is acknowledged that one bank reconciliation statement had not been signed as reviewed, however the review was competed accordingly as part of our normal monthly checking procedures.
- 8.5.4. **2010 Update**: Satisfactory. No issues noted in current year with all bank reconciliations evidenced as having been reviewed. No further action required.

#### 8.6. **Board Committee Meeting Attendance**

- 8.6.1. **2009 Observation**: Our review of meeting attendance registers highlighted that the General purposes committee meeting held on 16 September 2008 was non-quorate, with only attendee (from seven members). This does not represent best practice in relation to governance and undermines the validity of the meeting held at that time.
- 8.6.2. **2009 Recommendation**: We recommended that Board and committee members be reminded of their duty to attend the relevant meetings and that the calendar of meeting
- 8.6.3. be circulated to members at the start of the year. Further, we recommended that this be followed up by a reminder notice / email a month prior to the meeting.
- 8.6.4. **2009 Management Response:** This matter was discussed at the Board of Governors meeting on 26 October 2008. Attendance at Committee has since approved.
- 8.6.5. **2010 Update**: From our review of board and committee minutes, adequate attendance was maintained throughout the year at board meetings to ensure validity of meeting. No further action is therefore required. However, attendance of specific Governors has been raised as a separate point in the 2010 management letter within section 9.



#### 8.7. Related Party Disclosures

- 8.7.1. **2009 Observation**: As at the time of the 2009 audit, the related party disclosure forms had not yet been received by the College for all Board members.
- 8.7.2. **2009 Recommendation**: We recommended that the College ensure all related party disclosure forms be completed on an annual basis with non responses followed up on a timely basis in order to ensure that the College complies with best practice in relation to governance.
- 8.7.3. **2009 Management Response**: This item will be brought to the attention of Board Members at the next Board of Governors meeting. However the related party disclosure in question was for a new Board member who was possibly unfamiliar with our procedure.
- 8.7.4. **2010 Update**: At the time of our audit, the disclosure for one Board member was outstanding, however we acknowledge that this was in relation to a newly appointed member.
- 8.7.5. **2010 Recommendation:** We recommended that the College ensure all related party disclosure forms be completed on an annual basis with non responses followed up on a timely basis in order to ensure that the College complies with best practice in relation to governance.
- 8.7.6. **Priority**: Medium
- 8.7.7. **2010 Management Response**: As in previous years we will advise board members to complete these forms within the due date, and we will continue chasing up when the forms do not arrive.



#### 9. MANAGEMENT LETTER – 31 July 2010

9.1. Those additional matters which were highlighted as a result of our 2010 audit procedures are detailed below, along with our recommendations. These have been assigned a priority level in line with that explained in section 8.3.

#### 9.1.1. Attendance by Board Members at meetings

- 9.1.2. **Observation**: From our review of minutes, we noted two Governors who had failed to attend more than half the Board meetings held during the last year.
- 9.1.3. *Implication*: Attendance at board meeting is necessary to enable Governors to adequately discharge their duties. Failure to attend meetings undermines the proper governance of the College.
- 9.1.4. **Recommendation**: We recommend that attendance at board meetings is monitored and that reasons for non-attendance by Governors are noted and followed up where appropriate.
- 9.1.5. *Priority*: Medium
- 9.1.6. **Management Response**: Board members have in the past been encouraged to attend their committee meetings. Further discussion has taken place with those members whose attendance has been particularly low during the year.

#### 9.2. Supplier Statements

- 9.2.1. **Observation**: We noted when performing our audit testing that supplier statements had not been kept for the month of July due to staff absence.
- 9.2.2. *Implication*: Non retention of the supplier statements and absence of associated reconciliations represents a breakdown of a basic low level procedural control.
- 9.2.3. **Recommendation**: We recommend that supplier statements are retained on file following creditor account reconciliation until superseded by a more recent statement.
- 9.2.4. Priority: Low
- 9.2.5. *Management Response*: Agreed and noted. We will ensure that in future our normal monthly and year end internal procedures are followed, regardless of staff absences.



#### 10. CURRENT ISSUES

#### 10.1. Changes to measurement of price inflation in public sector pensions

On 22 June 2010, George Osborne, Chancellor of the Exchequer, announced a change of how price inflation will be measured for the purposes of annual increases in public sector pensions: from 2011, annual indexation will be accomplished by reference to the Consumer Price Index ("CPI") rather than the Retail Price Index ("RPI").

The impact of this has been accounted for by Hymans Robertson in determining the actuarial valuation for the pension scheme as at 31 July 2010. In doing this they have prepared their valuation on the basis that the change from RPI to CPI is a change in benefit. The gain arising from this valuation has therefore been taken directly to the Income and Expenditure account, in accordance with FRS 17. For Jewel & Esk College the past service gain for the current year has amounted to a credit of £1,208k to the income and expenditure account.

This accounting treatment is in line with others in the sector.

However, there is question as to whether the change from RPI to CPI should instead be treated as a change in assumption (rather than change in benefit). In this instance, the valuation would require to be reconsidered and any gain/ loss arising would be included within the balance sheet valuation rather than within the income and expenditure account.

The Accounting Standards Board ("ASB") is due to meet within the next few weeks to decide upon whether the change should be classified as a change in benefit or a change in assumption. Should they elect that this is a change in assumption, the valuation and accounts will require to be adjusted.

We will continue to review the situation and will keep the College appraised of the situation in order that any change can be acted upon accordingly. Note that should any change be made after the date of signing of the accounts, the current year results will be restated to reflect this within the financial statements for year ended 31 July 2011.

#### 10.2. ASB 'Policy Proposal: the future of UK GAAP'

The purpose of this consultation paper from the Accounting Standards Board (ASB) is to set out a proposed strategy for the future basis of UK GAAP and its convergence with International Financial Reporting Standards (IFRS).

The proposed approach is to work under the International Accounting Standards Board's (IASB) framework and to converge with IFRS to the fullest extent possible consistent with the needs of UK entities. The ASB's current intention is to issue an exposure draft withdrawing the separate body of literature currently referred to as UK GAAP and replacing it with new IFRS-based literature. Any modifications to the application in the UK of the underlying IFRS literature would be proposed at that stage.

The paper considers the future role of statements of recommended practice (SORPs) that are issued by industry or sectoral bodies that are recognised by the ASB. As a general principle, the ASB's view is that SORPs should only remain where there is a need arising from sector specific



issues not covered by guidance in accounting standards. The proposal is to restrict the number of SORPs to which the ASB provides any endorsement, however following consultation the ASB has reached the tentative decision (July 2010) that SORPs will be retained for certain Public Benefit Entities, including a SORP for Education.

The ASB intends issuing an exposure draft outlining its recommendations for the future of UK GAAP after considering the feedback on this paper.

It is noted that the SFC's expectation is that colleges will continue to converge with international financial reporting standards (IFRS) as UK GAAP converges over the next few years, and it appears likely that implementation will not take place before 2013. Consequently, it is highlighted that the transition timetables for IFRS that apply to the rest of the public sector do not therefore apply to colleges.



#### APPENDIX A

#### STATEMENT OF THE BOARD OF GOVERNORS' RESPONSIBILITIES

In accordance with the College's Constitution, the Board of Governors of Jewel & Esk College is responsible for the administration and management of the affairs of the College, including ensuring an effective system of internal control, and is required to present audited financial statements for each financial year.

The Board of Governors are responsible for ensuring that proper accounting records are maintained which disclose with reasonable accuracy at any time the financial position of the College and to enable it to ensure that the financial statements are prepared in accordance with the Constitution, the Statement of Recommended Practice: Accounting in Further and Higher Education Institutions and other relevant accounting standards. In addition within the terms and conditions of a Financial Memorandum agreed between the Scottish Funding Council and the College's Board of Governors, the Board of Governors, through its designated office holder, is required to prepare financial statements for each financial year which give a true and fair view of the College's state of affairs and of the surplus or deficit and cash flows for that year.

### In causing the financial statements to be prepared, the Board of Governors has ensured that:

- · suitable accounting policies are selected and applied consistently;
- judgements and estimates are made that are reasonable and prudent;
- applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- the financial statements are prepared on the going concern basis, unless it is inappropriate to presume that the college will continue in operation.

#### The Board of Governors has a responsibility to:

- ensure that funds from the Scottish Funding Council are used only for the purposes for which they have been given and in accordance with the Further and Higher Education (Scotland) Act 1992, the College's Financial Memorandum with the Funding Council and any other conditions which the Funding Council may from time to time prescribe;
- ensure that there are appropriate financial and management controls in place to safeguard public funds and funds from other sources;
- safeguard the assets of the College and hence to take reasonable steps to prevent and detect fraud;
- ensure reasonable steps have been taken to secure the economical, efficient and effective management of the College's resources and expenditure; and
- ensure sound corporate governance and the proper conduct of the college's operations.



#### APPENDIX A

- comprehensive Financial Regulations, detailing financial controls and procedures, approved by the Audit Committee and Finance Committee;
- a professional Internal Audit team whose annual programme is approved by the Audit Committee and endorsed by the Board of Governors and whose head provides the Board of Governors with a report on internal audit activity within the College and an opinion on the adequacy and effectiveness of the College's system of internal control, including internal financial control.

Any systems of internal financial control can, however, only provide reasonable, but not absolute assurance against material misstatement or loss.

#### Statement of disclosure to Auditors

- so far as the Board of Governors are aware, there is no relevant audit information of which the College's auditors are unaware, and
- it has taken all the steps that it ought to have taken as a Board of Governors to make itself aware of any relevant audit information and to establish that the college's auditors are aware of that information.
