Partner introduction

Financial statement audit

I have pleasure in presenting our final report to the Board for the 2014/15 audit. I would like to draw your attention to the key messages of this paper:

Conclusions from our testing	 The key risks and judgements in the audit process related to: Revenue recognition Management override of controls Future Funding Uncertainty Defined Benefit Pension Scheme We have identified one factual and one judgemental misstatement during our audit. Correction has been made for the factual misstatement as detailed in appendix 1. Based on the current status of our audit work, we anticipate issuing an unmodified audit opinion.
Insight	 We have made recommendations in the current year around finalising the Archibald House lease with Aberdeen City Council and reviewing the year end procedures for creditor recording. Prior year recommendations around year end-cut off procedures and the use of Aberdeenshire Council Payments Ledger have been appropriately addressed.
Status of the audit	 The audit is substantially complete subject to the completion of the following matters: Finalisation of quality control procedures; Receipt of signed management of representation letter; and Our review of events since 31 March 2015.

Audit quality is our number one priority. When planning our audit we set the following audit quality objectives for this audit: A robust challenge of the key judgements taken in the preparation of the financial statements. A strong understanding of your internal control environment. A well planned and delivered audit that raises findings early with those charged with governance.

Partner introduction (continued)

Public sector audit dimensions

We have commented below on the Audit Scotland impact dimensions with regard to Nestrans.

Financial sustainability

Financial sustainability continues to be one of the most significant challenges and risks for Nestrans and the wider public sector.

Nestrans in in the process of developing a 5 year plan in which future income and expenditure are forecasted. Uncertainty over future levels of funding from local government will be monitored through this budget forecast process.

Financial Management

The final outturn was an in year deficit of £2k against a breakeven target.

Nestrans closely monitors budget and actual expenditure through regular reporting to the Board.

Best Value (BV)

A plan is set by the Director each year that supports the delivery of the strategic priorities of the Partnership which identifies key projects and actions. Progress against this is monitored.

Additionally, the Nestrans Regional Transport Strategy sets out the challenges faced by Aberdeen City and Shire over the next 20 years and how this will be addressed.

Governance and Transparency

The Nestrans Board meets on a regular basis to assess performance of the Partnership against budget and to determine any risks affecting the entity.

Scope, nature and extent of audit

Our overall responsibility as external auditor of Nestrans is to undertake our audit in accordance with the principles contained in the Code of Audit Practice issued by Audit Scotland in May 2011.

The special accountabilities that attach to the conduct of public business, and the use of public money, means that public sector audits must be planned and undertaken from a wider perspective than in the private sector. This means providing assurance, not only on the financial statements and associated documents such as governance statements, but providing a view also, where appropriate, on matters such as regularity (or legality), propriety, performance and use of resources in accordance with the principles of Best Value and 'value for money'.

Our core audit work as defined by Audit Scotland comprises:

- Providing the Independent Auditor's Report on the financial statements;
- Providing the annual report on the audit to those charged with governance;
- Providing reports to management, as appropriate, in respect of the auditor's corporate governance responsibilities in the Code (including auditors' involvement in National Fraud Initiative (NFI)); and
- Submitting fraud returns, including nil returns, to Audit Scotland.


Significant risks

Revenue recognition

Risk Identified

ISA 240 states that when identifying and assessing the risks of material misstatement due to fraud, the auditor shall, based on a presumption that there are risks of fraud in revenue recognition, evaluate which types of revenue, revenue transactions or assertions give rise to such risks.

For the Partnership we have considered this risk to be around the completeness of requisitions from the constituent authorities and the Scottish Government given the significance of these to the organisation.



Key judgements

We have reviewed the treatment of income in the year to consider whether it is line with IFRS guidance and the Code. We have obtained a copy of the 2014/15 budget approved by the Partnership detailing the requisitions due from the partner Councils and the Scottish Government which have been agreed to the amount recognised by the Partnership. We have also agreed the amounts received through the bank account.

Deloitte response

- No issues noted from our review of the treatment of income in the year, which has been accounted for in line with the Code.
- We have agreed all income received to bank statements and journal entries.

Management override of controls

Risk Identified

International Standards on Auditing require auditors to identify a presumed risk of management override of control. This presumed risk cannot be rebutted by the auditor.

This recognises that management within Aberdeenshire Council acting on behalf of the Partnership is in a unique position to perpetrate fraud because of their ability to directly or indirectly manipulate accounting records and prepare fraudulent financial statements by overriding controls that otherwise appear to be operating effectively. The risk of management override of control is present in all entities.

This risk cannot be pinpointed to an account balance or potential error and therefore specific procedures to respond to the risk of management override of controls should be designed and performed.

Key judgements

Our audit work is designed to test for instances of management override of controls.

Deloitte response

- No issues noted around journal entries and other adjustments made in the preparation of the financial statements.
- Our review of accounting estimates for bias that could result in material misstatement due to fraud noted no issues.
- Retrospective review of management's judgements and assumptions relating to significant estimates reflected in last year's financial statements completed with no issues noted.
- We have not noted any transactions that appear to be outwith the course of normal business.

Critical accounting judgements and key sources of estimation

In the course of our audit of the financial statements, we consider the qualitative aspects of the financial reporting process, including items that have a significant impact on the relevance, reliability, comparability, understandability and materiality of the information provided by the financial statements. Our comments on the quality and acceptability of the accounting policies and estimates are discussed below.

We have assessed the disclosures based upon our review of the accounts and understanding of the organisation and the specific risks we identified as part of our planning process. We have not identified any other critical accounting judgements or key sources of estimation uncertainty that require to be disclosed. We have performed work as follows against each of these areas:

Future Funding Uncertainty

Management has made certain judgements about transactions involving uncertainty about future events. Disclosure has been made that there is a degree of uncertainty about future levels of funding from local government and hence funding for Nestrans. However, the Treasurer has determined that the level of uncertainty is not yet sufficient to provide an indication that the activities of the Partnership might be affected by the need to reduce level of service provision.

We have confirmed that a budget has been agreed for 2015/16 with funding levels in line with 2014/15, and indicative budgets are in place for 2016/17 confirming funding beyond April 2016, and therefore concur with the Treasurer's statement

Defined Benefit Pension Scheme

Nestrans participates in the North East Scotland Pension Fund, which is a multi-employer defined benefit scheme, where the share of the assets and liabilities applicable to each employer is not identified. This is therefore accounted for on a defined contribution basis as permitted by IAS 19.

We have reviewed the disclosure within the accounts against the Code and noted that it highlights Local Government Pension Schemes in relation to the participation of minor non-principal authorities that prepare their accounts in accordance with the Code (of which Nestrans is one) meet the criteria to account for as defined contribution plans.

Financial performance and outlook

Financial performance and outlook

Value for money

Nestrans budgeted a breakeven position for the year to 31 March 2015, with budgeted income and expenditure of £3.32 million. The final out-turn was a net overspend of £2,000, comprising £335,000 expenditure and £337,000 income both coming in lower than budget.

Overall financial and quality performance

The table below illustrates how the Board's performance compares to plan and prior year:

Comments on the key variances in 2014/15 are as follows:

Reduction in expenditure in the year is due to less projects being in progress either due to projects finishing during 2014/15 or projects being delayed. This includes a decline in costs for strategic roads largely due to certain non-recurring projects in the prior year now being completed, such as the feasibility study for the junction at Laurencekirk and refurbishment of the Fraserburgh bus station.

These savings are offset against an increase in walking and cycling costs of £259k due to two large cycle path projects in the current year of £168k at Riverside drive and £91k at the Dyce Railway to Parkhill road.

Financial Outlook

The 2015/16 budget was approved by the Partnership in February 2015 subject to anticipated funding levels being confirmed. This has been drafted to support the implementation of the Regional Transport Strategy. The Core Costs reflect the running costs of Nestrans and have been based on previous allocations, with adjustments applied in accordance with savings being achieved. The Non Core costs are for the development of projects within various Action Plans developed to support delivery of the Regional Transport Strategy and feasibility assessment to prepare Regional Transport Projects and Travel Planning. The capital budget has been grouped into projects matching the strands of the Regional Transport Strategy, the most significant being:

•Walking and Cycling - £915,000 •Bus Improvements - £584,250

Nestrans is in the process of developing a 5 year plan in which future income and expenditure are forecasted. This will assist in longer term planning when implemented.

We confirm that we have reviewed the arrangements in each of the four areas and have identified no issues in this regard.

The Board met on a regular basis during 2014/5 in order to review performance to date, and to monitor changes from budget.

We are comfortable with the fraud arrangements in place and confirm there have been no frauds of which management have made us aware.

Internal Audit services continue to be provided through Aberdeenshire Council's Chief Internal Auditor.

Your Annual Report

Our comments on your annual report

We welcome this opportunity to set out for the Partnership our observations on the annual report. We are required to read the "front half" of your annual report to consider consistency with the financial statements and any apparent misstatements. Here we summarise our observations on your response to these areas:

Deloitte response

The Management Commentary reflects on those matters companies are require to disclose under the Companies Act 2006, as adapted for local authorities. This includes description of the principal risks and uncertainties facing the Partnership, a review of performance in the Management year, a measurement of progress against performance indicators and Commentary commentary on going concern. We have read the Management Commentary in full in order to ensure that it is in line with our understanding of the Partnership and complies with the required guidance on Management Commentary. The Governance Statement reports that Nestrans is in compliance with the aspects of the UK Corporate Governance Code which are set out within the guidance as being applicable to Authorities. The format and content of the statement is consistent with the **Governance Statement** requirements of the Code and concludes that reasonable assurance can be placed on the adequacy and effectiveness of the Partnership's Internal Control System in the year to 31 March 2015. No areas have been highlighted as requiring improvement, which is consistent with the findings of our audit. The remuneration report has been prepared in accordance with the requirements of the Local Authority Accounts (Scotland) Regulations 2014, disclosing the remuneration of senior employees working for the Partnership. The Partnership does not make any payments to any members of the Partnership, whether elected Member or otherwise appointed, by way of salary, enhanced pension benefits or **Remuneration Report** reimbursement of expenses. We are satisfied that the remuneration report has been prepared in accordance with the amendment regulations and is consistent with the findings of our audit.

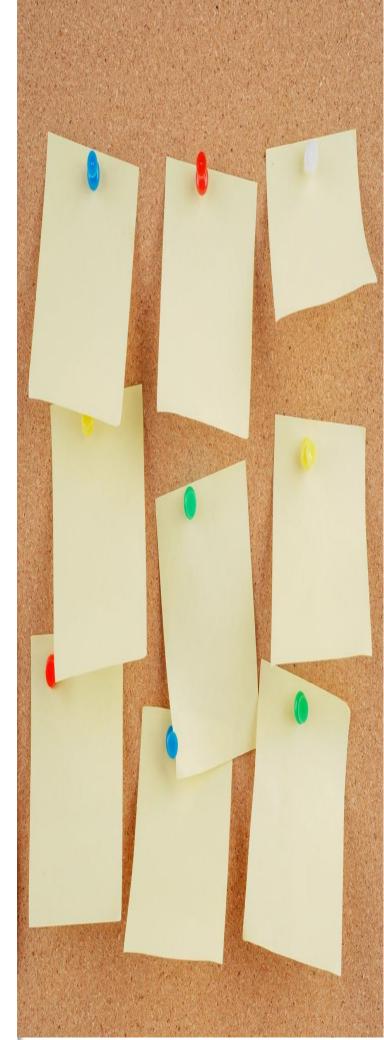

Audit adjustments



Corrected misstatements

• A factual misstatement was noted within creditor testing for £93,537.22. This error has been adjusted for. The misstatement occurred due to a member of staff in Aberdeen City Council failing to notify Nestrans of a delay in a project, which meant that it was not possible to complete the job by the end of the financial year, as previously advised.

Uncorrected misstatements

Our audit approach involves testing a sample of items at year end. From a sample of 31 items tested, an error was noted in one creditor as noted above. There is theoretically the potential for additional misstatements in the remaining population that remains untested. This is judgmentally calculated at £26,763.92. As this theoretical adjustment is not material, it has not been adjusted for.

Disclosure misstatements

• Auditing standards require us to highlight significant disclosure misstatements to enable audit committees to evaluate the impact of those matters on the financial statements. We have noted no material disclosure deficiencies in the course of our audit work.

Fraud responsibilities and representations

Responsibilities explained



Responsibilities

The primary responsibility for the prevention and detection of fraud rests with management and those charged with governance, including establishing and maintaining internal controls reliabilitv of financial reporting, over the effectiveness and efficiency of operations and compliance with applicable laws and regulations. As auditors, we obtain reasonable, but not absolute, assurance that the financial statements as a whole are free from material misstatement. whether caused by fraud or error.

Required representations

We have asked the Partnership to confirm in writing that you have disclosed to us the results of your own assessment of the risk that the financial statements may be materially misstated as a result of fraud and that you are not aware of any fraud or suspected fraud that affects the entity.

We have also asked the Partnership to confirm in writing their responsibility for the design, implementation and maintenance of internal control to prevent and detect fraud and error.

Audit work performed

- In our planning we identified the risk of fraud in revenue recognition and management override of controls as key audit risks for the Partnership.
- During course of our audit, we have had discussions with management and those charged with governance.

Concerns

• As set out above we have identified the risk of fraud in other income recognition and management override of controls as a key audit risk for your organisation.

During our current year audit, we noted the following action plan points which we believe would assist the Partnership.

Accuracy of year end creditors	During testing, one creditor balance was found to be overstated by £94k. The misstatement affected income, expenditure and creditor balances. Deloitte recommend that Nestrans reviews its year end procedures of creditor accuracy to ensure that it is advised of any changes to year end creditor balances.	Agreed. Discussions have already taken place between Nestrans and the Partner Councils and it has been agreed that a formal meeting will be held at year end to go through the works programme, to ensure that all the necessary information on progress/delivery has been confirmed, giving time for any outstanding queries to be resolved before the financial ledgers are closed. Lease agreement with Aberdeen City Council remains outstanding	Nestrans has leased Archibald House on King Street from Aberdeen City Council since 28/2/12, with the lease set to expire 31/3/16. While rental amounts have been agreed and accrued, the lease has not been finalised, thus no rent has been paid. Deloitte recommend that agreement is sought so that balances can be settled to remove historic creditors from the balance sheet.	Agreed. The delays regarding to this have partly been due to the issue that Aberdeen City Council are Nestran's legal advisors, however, as the lease is between Aberdeen City Council and Nestrans they cannot act as Nestran's legal advisors in relation to the lease, as this would pose a conflict of interest. Arrangements are being progressed for Aberdeenshire Council to provide legal advice in this instance, but this cannot be undertaken until a service level agreement is in place. Finance Business Partnering – A Public Sector View

Deloitte's research into Finance Business Partnering has analysed the responses of 75 senior Finance executives from UK headquartered organisations, including 20 public sector organisations across central government departments, arm's length bodies and agencies. The results were as follows:
