Discretionary Fund	Full-time students must be taking out the maximum student loan to be eligible. All students may apply for financial help, but payments are made at the discretion of universities and are based on an assessment of need.			
Discretionary Childcare Fund	Must be taking out the maximum student loan to be eligible. Payments are made at the discretion of universities and are based on an assessment of need.			
University bursaries and scholarships	Eligibility criteria is set by each university.			
Education Endowments	There are a number of educational trusts and charities in Scotland that offer bursaries. Eligibility often depends on the student's country of origin and financial circumstances.			

Notes: Information is for Scottish students studying in Scotland. EU students are eligible for SAAS to pay their tuition fees if the student is an EU national (or is the family member of an EU national), has been ordinarily resident in a member state of the EU for three years and is taking a full-time course in Scotland.

1. Tuition fees are £1,820 for first degree or PGDE (postgraduate diploma in education) courses. Fees are paid directly to the institution the student attends.

2. 'Undergraduate' eligibility also includes PGDE, HNC, HND, degree and nursing and midwifery diploma and degrees. Students are only entitled to loan support if they are under 50 or aged 50 to 54 and plan to return to employment after completing the course.

3. Postgraduate courses not eligible for funding are as follows: courses below the Scottish Credit Qualification Framework (SCQF) level 11, courses outside the UK, postgraduate masters courses, PhDs, two year full-time diploma courses (except the two year diploma in educational psychology), diploma courses outwith Scotland where a similar course exists in Scotland, and intercalated postgraduate courses taken as part of an undergraduate or graduate entry medicine, dentistry or veterinary medicine course.
