Our audit at a glance



We fulfil our responsibilities per ISAs (UK) and the Audit Scotland Code of Audit Practice throughout our work.



Materiality is set at 2% of gross expenditure based on 2016/17 audited information (£165,000). Previous year it was 1% of gross expenditure reflecting the first year of our audit appointment.



Performance materiality is set at 75% and trivial is 5% of materiality. This reflects minimal audit adjustments in prior year and our understanding of the Authority in a year 2 of our audit cycle.

An audit underpinned by quality and adding value to you



We have identified the following significant risks: management override of controls; income recognition; and expenditure recognition as set out in International Standards on Auditing (ISAs UK) and the FRC's Practice Note 10.



At the planning stage we have recognised an area of audit focus around the recognition of the Gateway Centre lease transactions and defined benefit pension liabilities.



Our audit is undertaken in accordance with the Code of Audit Practice. We do not consider a full wider scope audit is appropriate to the Authority. However, we will consider the Authority's financial sustainability and governance arrangements as part of our audit.

Overarching principles of our audit

Our audit is risk based and undertaken in accordance with the relevant International Auditing Standards (ISAs) (UK and Ireland) and the Audit Scotland Code of Audit Practice 2016.

Our overall objective is a robust, quality-focused external audit which adds value through wider insights and challenge. Our audit foundations are:

- professional scepticism
- a focus on audit risks and key areas of management judgement
- · use of specialists to support our work where relevant
- using IDEA our data analytical software to effectively and efficiently test your balances
- clear and upfront communications, with regular updates during the year
- clear reporting with focused actions which will support you in improving your controls/operations
- we will liaise effectively with Internal Audit.

Adding value

Specific areas we will look to add value to Loch Lomond & the Trossachs National Park Authority during 2017/18, identified as part of our planning work and reflection on prior year include:

- We will act on the 'learning the lessons' sessions we held after the first year audit and ensure that there is a smooth handover to the new audit team.
- We will actively share relevant Audit Scotland and Grant Thornton publications with Senior Management and the Audit and Risk Committee, identifying particular areas for consideration.
- Should any new accounting changes or governance updates emerge during the year we will providing a briefing for the Audit and Risk Committee. We will also pro-actively work with management during the year to discuss any emerging matters, including areas such as EU withdrawal, and seek to reach agreement on the treatment of these in advance of year-end.
- We will share the Scottish Public Sector Transparency report we will produce for Audit Scotland at the end of December 2017, and alongside our UK Grant Thornton Transparency Report (March 2018).

Audit approach and materiality



We undertake your audit in accordance with International Standards in Auditing (UK) (ISAs) and the Audit Scotland Code of Audit Practice (May 2016). On an annual basis we are required to give an opinion as to whether the Financial Statements:

- give a true and fair view
- · have been properly prepared in accordance with relevant legislation and standards
- the wider information contained in the annual report and accounts e.g. Performance Report, the Accountability report including the Corporate Governance Report and Governance Statement, management commentary, that are consistent with the disclosures in the financial statements
- regularity of expenditure
- audited parts of the remuneration and staff report have been prepared in accordance with the guidance

Materiality

In performing our audit we apply International Standards on Auditing (UK) 320: *Materiality*. Our materiality for 2017/18 is shown below. We will revise this on receipt of the unaudited financial statements for 2017/18 once received.

Overall materiality

We have calculated overall materiality in line with gross expenditure, as is recognised as a common measure in the public sector. This is in line with prior year. As this is our second year of the audit, and taking into account the level of errors and adjustments in prior year, and the context of your activities we feel it is appropriate to increase our materiality benchmark to 2% (1% in 2016/17). Under our audit methodology we typically set materiality within the benchmark range of 0.5% up to 2%.

Trivial

Under ISA 540 we are required to set an amount below which we consider misstatements would be clearly trivial, and therefore when accumulated we would not expect that they would have a material impact on the financial statements. We have set our reporting threshold at 5% of materiality. Misstatements below this level would not be reported to the Audit and Risk Committee

Misstatements above trivial (corrected and uncorrected) will be reported to the Audit and Risk Committee in our Annual Report to those charged with governance.

Performance materiality

Performance materiality represents the amount set for the financial statements as a whole to reduce the probability that the aggregate of uncorrected and undetected misstatements exceed materiality. Based on our audit experience in 2016/17 we have increased this for 2017/18 to 75% (65% in prior year). This does not impact on the financial statement balances we undertake substantive testing on, as all balances are in scope per prior year, but will impact on sample sizes.

Going concern considerations

As auditors, we are required to "obtain sufficient appropriate audit evidence about the appropriateness of management's use of the going concern assumption in the preparation and presentation of the financial statements and to conclude whether there is a material uncertainty about the entity's ability to continue as a going concern" (ISA (UK) 570).

We will review management's assessment of the going concern assumption and evaluate the disclosures in the financial statements.

A risk based audit methodology

Our understanding of Loch Lomond & the Trossachs National Park Authority

This is our second year as the external auditors of the Authority appointed under the Audit Scotland framework. In 2016/17, Loch Lomond & the Trossachs National Park Authority received funding of £7.365 million and generated income from planning fees, projects ad other operating income of £1.017 million. As at December 2017, management forecast a breakeven position for the year. This is in line with the approved financial plan for the year.

The National Park Partnership Plan 2018-2023 was approved by the Authority in December and has been sent for Scottish Ministerial approval. The Plan, sets out how the Authority and its key partners will work together to tackle key issues facing the national park and to widen the social, environmental, cultural and economic benefits that it offers. A new Corporate Plan is currently underdevelopment which will align the Authority's objectives to the National Park Partnership Plan.

The Authority has forecast achieving its balanced budget for the year ended 2017/18. Budgets are managed across key operational areas and projects and management continue to review and adjust these to respond to changing pressures.

Wider Scope – Smaller Body approach

For smaller bodies the Audit Scotland Code of Practice permits auditors to not apply the full wider scope audit. In our judgement, taking into account the nature of Loch Lomond & the Trossachs National Park Authority operating activity and income and expenditure streams, we feel it is appropriate to treat you as a smaller body under the Code. However, we will update our understanding of your arrangements for ensuring financial sustainability as well as your governance arrangements in place to support the delivery of the authority's strategic outcomes as part of our audit.

Other areas of audit focus

Through our audit planning process we identify areas and accounts that due to the nature of a transaction, disclosure or account balance in the financial statements are inherently more at risk of material misstatement within the financial statements.

Overview of other areas of audit focus identified at planning and our proposed approach

Gateway Business Centre

The work upgrading the Gateway Centre was completed during the year. The centre is being leased to a tenant who provided a contribution to the development of £54,000. There is an ongoing dispute around the design specifications of the centre and resulting delays in the third party taking tenancy of the centre.

Management have sought legal advice on the matter. There is a risk that Loch Lomond & the Trossachs National Park Authority will be exposed to lost revenue through delays in the tenancy being taken up as well as potential costs in correcting the design.

- Understanding the current status of the Gateway Centre tenancy arrangement and review the appropriateness of how the transactions in the year are reflected within the financial statements
 - Consider the independent legal advice provided to the client on the matter to determine if the Authority is exposed to any potential liabilities unrecorded in the financial statements

Pension scheme liabilities

The Authority is a member of the Strathclyde Pension Fund defined benefit pension scheme. The Authority recognises its share of the defined benefit pension scheme assets and liabilities. These are valued through an actuarial valuation. As at 31 March 2017 the Authority recognised a net pension liability of £6.399 million. While we have no underlying concerns around the historic accounting treatment, given the scale of the liability recognised and level of judgement in the assumptions used to value the scheme, we recognise an additional

- Review of accounting for post employment benefits and confirm that it complies with the FReM and IAS 19: *Employee benefits*.
- Confirming that the valuation is consistent with the actuaries' valuation and that the actuarial assumptions underpinning the valuation are reasonable and reflective of the Authority's circumstances.



The audit fee is calculated in accordance with guidance issued by Audit Scotland. In accordance with the Audit Scotland guidance we can increase the fee by up to 20% from the base fee set by Audit Scotland, depending on risk factors identified by us as your external auditors. We cannot reduce the fee from the baseline set out by Audit Scotland. The above proposed fee, set at the base fee, has been agreed with management. The fee is based on the following assumptions:

- supporting schedules to all figures in the accounts are supplied by the agreed dates and in accordance with the agreed upon information request list
- the scope of the audit, and the Authority's activities will not change significantly from planned
- Loch Lomond & the Trossachs National Park Authority will make available management and accounting staff to help us locate information and to provide explanations. We reserve the right to charge an additional fee for any additional work.
- We will only receive (and audit) 3 sets of accounts (1st draft; amended draft and final)
- Specific balances such as pensions and valuations of assets are supported by an independent specialist.

Independence and ethics

We confirm that there are no significant facts or matters that impact on our independence as auditors that we are required or wish to draw to your attention.

We have complied with the Auditing Practices Board's Ethical Standards and therefore we confirm that we are independent and are able to express an objective opinion on the financial statements.

Full details of all fees charged for audit and non-audit services will be included in our Annual Report to those charged with governance at the conclusion of the audit.

We confirm that we have implemented policies and procedures to meet the requirements of the Auditing Practices Board's Ethical Standards.

We are required by auditing and ethical standards to communicate any relationships that may affect the independence and objectivity of the audit team.

We can confirm no independence concerns have been identified.

Fraud arrangements

The term fraud refers to intentional acts of one or more individuals amongst management, those charged with governance, employees or third parties involving the use of deception that result in a material misstatement of the financial statements. In assessing risks, the audit team is alert to the possibility of fraud at Loch Lomond & the Trossachs National Park Authority.

As part of our audit work we are responsible for:

- identifying and assessing the risks of material misstatement of the financial statements due to fraud in particular in relations to management override of controls.
- Leading a discussion with those charged of governance (for Loch Lomond & the Trossachs National Park Authority this is assumed to be the Audit and Risk Committee) on their view of fraud. Typically we do this when presenting our audit plan and in the form of management and those charged with governance questionnaires.
- designing and implementing appropriate audit testing to gain assurance over our assessed risks of fraud
- responding appropriately to any fraud or suspected fraud identified during the audit.

As auditors we obtain reasonable but not absolute assurance the financial statements as a whole are free from material misstatement, whether due to fraud or error.

We will obtain annual representation from management regarding managements assessment of fraud risk, including internal controls, and any known or suspected fraud or misstatement. The primary responsibility for the prevention and detection of fraud rests with management and those charged with governance including establishing and maintaining internal controls over the reliability of financial reporting effectiveness and efficiency of operations and compliance with applicable laws and regulations.

It is Loch Lomond & the Trossachs National Park Authority's responsibility to establish arrangements to prevent and detect fraud and other irregularity. This includes:

- developing, promoting and monitoring compliance with standing orders and financial instructions
- developing and implementing strategies to prevent and detect fraud and other irregularity
- receiving and investigating alleged breaches of proper standards of financial conduct or fraud and irregularity.

Throughout the audit we work with the Authority to review specific areas of fraud risk, including the operation of key financial controls. We also examine the policies in place, strategies, standing orders and financial instructions to ensure that they provide a strong framework of internal control.

All suspected frauds and/or irregularities over £5,000 are reported to Audit Scotland by us as your auditors on an annual basis (no later than end of April 2018)
